

NORTH DAKOTA STATE BOARD OF CHIROPRACTIC EXAMINERS

Minutes of the Special Conference Call Meeting of the North Dakota State Board of Chiropractic Examiners held January 14, 2019.

Call to Order: Dr. Michael Remmick called the meeting to order at 12:30 PM CST.

Roll Call: Those present included, Dr. Michael Remmick, Dr. Dion Ficek, Dr. Eric Froehling, Dr. Steven Pederson, Dr. Kent Yohe, Assistant Attorney General Ms. Allyson Hicks, and Executive Director Lisa Blanchard.

Public: There were public on the conference call, but an official roll was not taken.

Reading of the Mission Statement: Dr. Remmick.

As this was a special meeting, no additions to the agenda were allowed.

Board Business:

HB1279. This bill is an amendment to NDCC 43-06-04; Board of chiropractic examiners – Members – Term of Office. A motion was made by Dr. Froehling, second by Dr. Yohe, that the ND Board of Chiropractic Examiners oppose this bill and testify as such when the committee hearing is scheduled. A roll call vote was taken with all members of the board voting in the affirmative (5-0). Motion passed. If scheduling allows, Dr. Froehling will represent the Board for the testimony.

HB1253. This bill is an amendment to NDCC 12.1-33-02.1; Prior conviction of a crime not bar to state licensures – Exceptions. A motion was made by Dr. Yohe, second by Dr. Ficek, that the ND Board of Chiropractic Examiners oppose this bill and testify as such. A roll call vote was taken with all members of the board voting in the affirmative (5-0). Motion passed. The committee hearing is scheduled for Tuesday, January 15, 2019. Executive Director Blanchard will represent the Board and provide testimony. Ms. Hicks will assist in the preparation of the testimony.

SB2126. This bill is an amendment to NDCC 43-51-06; Licensure without examination. A motion was made by Dr. Froehling, second by Dr. Yohe, that the ND Board of Chiropractic Examiners oppose this bill and testify as such. A roll call vote was taken with all members of the board voting in the affirmative (5-0). Motion passed. The committee hearing is scheduled for Thursday, January 17, 2019. Executive Director Blanchard will represent the Board and provide testimony. Ms. Hicks will assist in the preparation of the testimony.

SB2127. This bill is an amendment to NDCC 43-51-01 and NDCC 43-51-11.1 additionally to create a new section 43-51-11.2; Military Spouses and Military Dependents. A motion was made by Dr. Yohe, second by Dr. Ficek, that the ND Board of Chiropractic Examiners oppose this bill and testify as such when the committee hearing is scheduled. A roll call vote was taken with all members of the board voting in the affirmative (5-0). Motion passed. Executive Director Blanchard will represent the Board and provide testimony. Ms. Hicks will assist in the preparation of the testimony.

The next meeting is scheduled for January 24, 2019 in Bismarck, ND. The New Doctor Seminar is scheduled for January 25, 2019 at 6:30 PM.

Adjourn: A motion was made by Dr. Pederson, second by Dr. Froehling, to adjourn the meeting. Motion passed. The conference call ended at 1:35 PM CST.
