## Minutes of the Special Meeting of the North Dakota State Board of Chiropractic Examiners held June 15, 2022 via Zoom.

Call to Order: Dr. Eric Froehling called the meeting to order at 12:02 PM CST.

**Roll Call:** Those present included Dr. Froehling, Dr. Ten Broek, Dr. Remmick, Dr. Ficek, Dr. Yohe, Assistant Attorney General Ms. Allyson Hicks, SAAG Mr. Nathan Svihovec, and Executive Director Lisa Blanchard. Absent: Ms. Mellum and Ms. Botz. Ms. Botz was absent at the roll call but joined the meeting at 12:17 PM. Public: There were public attendees on the Zoom.

Reading of the Mission Statement: Dr. Froehling

As this was a special meeting, no additions to the agenda were permitted.

## Agenda:

Dr. Jacob Schmitz - Opinion in North Dakota Supreme Court No. 20210135 (Schmitz v. State Board of Chiropractic Examiners). Ms. Hicks and Mr. Svihovec provided general information and explanation of the Supreme Court's opinion 2022 ND 133 issued on May 26, 2022. Ms. Hicks informed the Board that a motion for rehearing had been submitted by Dr. Schmitz and that until the Supreme Court issues their decision regarding that motion, the Board has no action to take. Further explanations were provided to Board member questions on what the process moving forward may potentially be and an estimated timeline. The Board took no action at this meeting, they only received information.

Per Diem. A motion was made by Dr. Ficek, second by Dr. Remmick, to pay a ½ per diem payment (\$125) for this meeting. A roll call vote was taken with Ten Broek, Ficek, and Botz voting in the affirmative. Froehling, Remmick, and Yohe voting in the negative. Mellum absent. (3-3-1) Motion fails.

A motion was made by Dr. Remmick, second by Dr. Ficek, to pay a full per diem payment (\$250) for this meeting. A roll call vote was taken with Froehling, Ten Broek, Remmick, Ficek, and Botz voting in the affirmative. Yohe voting negative. Mellum absent. (5-1-1) Motion passes.

**Adjourn:** A motion was made by Dr. Remmick, second by Dr. Yohe, to adjourn the meeting. Motion passed. The meeting ended at approximately 12:26 PM CST.
